#### AUDIT SUMMARY

#### **Results in brief**

In the areas we audited, SCORE operations complied with applicable requirements and provided adequate safeguarding of public resources. SCORE also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of SCORE from January 1, 2015 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about SCORE's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

• Open public meeting minutes

• Payments/expenditures

• Financial condition

#### Financial

#### **INFORMATION ABOUT THE ENTITY**

The South Correctional Entity, doing business as SCORE, operates a consolidated correctional facility and was established February 25, 2009, under the Original Interlocal Agreement by seven participating municipal governments known as the, "member cities," – Auburn, Burien, Des Moines, Federal Way, Renton, SeaTac and Tukwila – under the authority of the Interlocal Cooperation Act (RCW 39.34). The Original Interlocal Agreement was amended and restated October 1, 2009, known as the, "Formation Interlocal Agreement," and named the City of Des Moines as the, "host city," and the remaining member cities as, "owner cities." Member city payments represent approximately 57 percent of the Entity's annual revenues.

The Entity has the power to acquire, construct, own, operate, maintain, equip and improve a correctional facility known as the, "SCORE Facility," and to provide correctional services and functions incidental thereto, for the purpose of detaining arrestees and sentenced offenders in the furtherance of public safety and emergencies within the jurisdiction of the member cities.

The City of Renton has chartered the SCORE Facility Public Development Authority (the Authority) to finance costs of acquiring, constructing, improving and equipping the SCORE Facility. The Authority issued \$86,235,000 in bonds in November 2009. The Entity is obligated to make payments to the Authority for principal and interest and any administrative costs. Each owner city is obligated to pay an amount equal to its capital contribution based on average population. Each member city is obligated to pay its allocable portion of costs of maintenance and operation of the SCORE Facility, including any debt issued to finance such costs.

In 2015, the Entity had approximately 142 employees and an operating budget of approximately \$34.6 million.
