AUDIT SUMMARY

Results in brief

In the areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the City of Union Gap from January 1, 2014 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Safeguarding of assets
- Open Public Meetings Act
- Procurement
- Budget compliance
- Disbursements and credit cards
- Restricted funds
- Surplus property
- Payroll

INFORMATION ABOUT THE CITY

The City of Union Gap serves 6,047 citizens in Yakima County. The City provides services including water, sewer, garbage, police, emergency medical, street maintenance and improvement, parks and recreation, and general administration. An elected, seven-member Council and an independently elected Mayor govern the City. The Council appoints a City Manager to oversee the City's daily operations, as well as, its 115 employees. The City operated on expenditures of approximately \$10.4 million and \$11 million in 2014 and 2015, respectively.
