AUDIT SUMMARY

Results in brief

We identified areas in which the Authority could make improvements.

We recommend the Authority strengthen internal controls over operations. Specifically, the Board should better monitor Authority cash receipting, payroll, and disbursements to ensure adequate oversight and monitoring to safeguard public resources and compliance with Authority policies. Additionally, we recommend that the Authority comply with established Local Government Records Retention Schedules.

We appreciate the Authority's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of the Downtown Pasco Development Authority from January 1, 2013 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Authority's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Cash receipting
- Credit cards

- General disbursements
- Payroll
