AUDIT SUMMARY

Results in brief

In most areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to City management in a letter dated September 27, 2016, related to the City's allocation of expenditures to proprietary funds. We appreciate the City's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of the City of Wenatchee from January 1, 2015 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Cost allocation plans
- Transfer of fire department
- Cash receipting

- Interfund loans
- Budget compliance

INFORMATION ABOUT THE CITY

The City of Wenatchee serves approximately 33,000 citizens in Chelan County. The City provides a variety of services including water, sewer, police, parks and recreation, planning and economic development. The City also owns and operates a cemetery.

An elected, seven-member City Council and an independently elected Mayor govern the City. The Mayor and Council appoint management to oversee the City's daily operations as well as its 155 employees. For fiscal year 2015, the City's revenue was \$54.6 million, including operating and capital contributions.
