## **AUDIT SUMMARY**

#### Results in brief

In the areas we audited, Housing Authority operations complied with applicable requirements and provided adequate safeguarding of public resources. The Housing Authority also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of the Housing Authority of the City of Renton from January 1, 2014 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Housing Authority's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Financial condition
- Section 8 vouchers
- Procurement: equipment purchase
- Procurement: public works projects change orders and prevailing wage

# INFORMATION ABOUT THE HOUSING AUTHORITY

The Housing Authority of the City of Renton administers housing programs for low-income families and the elderly. The Housing Authority accomplishes this through construction, financing and operating subsidies from the U.S. Department of Housing and Urban Development (HUD).

An appointed, five-member Board of Commissioners governs the Housing Authority. The Mayor of the city of Renton appoints four of the Commissioners and a Resident Commissioner; each for a five-year term. In addition, the Board appoints an Executive Director to oversee the Housing Authority's daily operations as well as its 40 employees. For fiscal years 2014 and 2015, the Housing Authority had operating expenses of \$14.2 million and \$15.4 million, respectively.
