## **AUDIT SUMMARY**

#### Results in brief

In most areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to District management in a letter dated October 11, 2016, related to procurement. We appreciate the District's commitment to resolving those matters.

#### About the audit

This report contains the results of our independent accountability audit of Cowlitz County Fire Protection District No. 5 from January 1, 2013 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Monitoring of ambulance billings
- Fuel purchases
- Open public meeting minutes
- Payroll/personnel

- Credit card payments
- Procurement (bidding/prevailing wage)

## INFORMATION ABOUT THE DISTRICT

Cowlitz County Fire Protection District No. 5 is a combination fire and emergency medical services department operating from two stations located in the Kalama area. The District serves a population of just over 5,400 residents with a large industrial community. The District provides fire control and prevention services, public education, advanced life support emergency medical services, vehicular rescue and technical rescue. The District is licensed by the state of Washington as an advanced life support trauma verified service.

An elected, three-member Board of Commissioners governs the District. The Commission appoints a Fire Chief to oversee the District's daily operations as well as its nine employees and 18 volunteers. For the years under audit, the District operated on an average annual budget of approximately \$1,891,000.
