AUDIT SUMMARY

Results in brief

In most areas we audited, Commission operations complied with applicable requirements and provided adequate safeguarding of public resources. The Commission also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to Commission management in a letter dated October 18, 2016, related to contracts and agreements. We appreciate the Commission's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of the Washington State Hop Commission from January 1, 2012 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Commission's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Assessment billing and receipting
- Contracts and agreements
- Open Public Meetings Act
- Disbursements
- Credit cards
- Employee reimbursements

INFORMATION ABOUT THE COMMISSION

The Washington State Hop Commission was established by state law to provide research, public relations, and issue management, statistical and promotional services for the state's hop industry. It is funded by assessments on hop producers or processors.

The Commission is governed by an elected eight-member Board of Commissioners. The Commission operated on approximately \$530,000, \$485,000, \$532,000 and \$697,000 in assessment revenue for 2012, 2013, 2014 and 2015, respectively.
