AUDIT SUMMARY

Results in brief

In the areas we audited, Port operations complied with applicable requirements and provided adequate safeguarding of public resources. The Port also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Port of Columbia County from January 1, 2013 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Port's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Financial condition
- Promotional hosting
- Cash disbursements
- Credit cards
- Procurement (bidding/prevaling wage)

INFORMATION ABOUT THE PORT

The Port of Columbia County leases commercial space to manufacturers, retail, service businesses and governmental agencies to stimulate economic growth in Columbia County and serves as the Lead Economic Development Agency for Columbia County.

An elected, three-member Board of Commissioners governs the Port. The Board appoints a District Manager and a District Auditor to oversee the Port's daily operation. For the years under audit, the Port operated on annual budgets of approximately \$500,000.
