### **AUDIT SUMMARY**

#### Results in brief

In the areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of the City of Chewelah from January 1, 2014 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Safeguarding of small and attractive assets such as computers
- Procurement (bidding/prevailing wage)
- Payroll/personnel

- Conflict of interest/ethics laws
- Cost allocation plans
- Police department

### INFORMATION ABOUT THE CITY

The City of Chewelah was incorporated in 1903 and serves approximately 2,650 residents in Stevens County. It provides an array of services including public safety, fire protection, street improvement, water, sewer, electric, garbage, parks and recreation, cemetery and general administrative services. The City also operates a museum and an airport.

An elected, seven-member Council with a separately elected Mayor governs the City. The Mayor appoints a City Administrator to oversee the City's daily operations. For fiscal year 2014 and 2015 the City operated on an annual budget of approximately \$7 million and \$8 million, respectively.
