AUDIT SUMMARY

Results in brief

In the areas we audited, County operations complied with applicable requirements and provided adequate safeguarding of public resources. The County also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of Cowlitz County from January 1, 2015 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the County's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Use of restricted funds
- Payroll
- Building and planning permits
- Cash receipting Corrections, Sheriff, Treasurer, Clerk of the Court, Public Works, and Hoffstadt Bluff and Silver Lake gift shops
- County fair
- Disbursements
- Procurement of architectural and engineering services
- Safeguarding of small and attractive assets

INFORMATION ABOUT THE COUNTY

Cowlitz County serves approximately 104,280 citizens residing in Southwest Washington. The County is administered by an elected three-member Board of Commissioners. In 2015, the County operated on an annual budget of approximately \$174 million.

The County currently employs 514 full-time and 89 part-time workers, 350 of whom are currently members of one of 12 bargaining units. The employees provide an array of services, including planning and development, water, sewer, road construction, parks and recreation, human services, public safety, civil and criminal courts and geographic information services.
