## AUDIT SUMMARY

### Results in brief

In the areas we audited, Port operations complied with applicable requirements and provided adequate safeguarding of public resources. The Port also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of the Port of Quincy from January 1, 2014 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Port's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Surplus of property
- Procurement of Public Works
- Leave usage and accrual
- Controls over disbursements

## INFORMATION ABOUT THE PORT

Grant County Port District No. 1, doing business as the Port of Quincy, was formed in 1958 and is located in Grant County. The Port operates five industrial development parks as well as an intermodal park to promote the existing industrial facilities and develop new facilities to attract businesses to the area. The Port also operates the Quincy Municipal Airport, the Colockum Ridge Golf Course, and the Quincy Valley Business and Conference Center.

An elected, three-member Board of Commissioners governs the Port. The Board appoints an Executive Assistant who is also the clerk of the Board and they appointed a Comptroller in January 2014. For fiscal years 2014 and 2015, the Port had annual revenues (Operating and Non-Operating) of \$4,643,253 and \$1,908,136, respectively.
