AUDIT SUMMARY

Results in brief

In most areas we audited, Town operations complied with applicable requirements and provided adequate safeguarding of public resources. The Town also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to Town management in a letter dated October 27, 2016, related to cost allocation addressed in the management letter. We appreciate the Town's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of the Town of Bucoda from January 1, 2014 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Town's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Open public meetings
- Financial condition
- General revenues and expenditures
- Cost allocation
- Procurement purchases
- Procurement public works

- Self-insurance
- Utilities
- Payroll
- Cash receipting

INFORMATION ABOUT THE TOWN

The Town of Bucoda, located in Thurston County, was incorporated in 1910 and currently has a population of approximately 560. The Town provides its citizens, directly or through contract, services including public safety, fire prevention, refuse collection, street improvements, parks and recreation and general administrative services. In addition, the Town operates a water system and a recreational campground.

An elected, five-member Council and a separately elected Mayor govern the Town. For fiscal year 2014 and 2015, the Town operated on annual budgets of approximately \$1,200,000 and \$440,000, respectively. The Town had two full-time employees and one part-time employee for the duration of fiscal years 2014 and 2015, with two part-time employees hired as summer help in 2015.
