AUDIT SUMMARY

Results in brief

In most areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the City of Connell from January 1, 2013 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Credit card user agreements
- Police Department – confidential funds
- Police Department – safeguarding of property
- Police Department – seized property reports
- Utility charges
- Cost allocation plan
- Procurement, prevailing wages, and change orders
- Property sale – pharmacy building
- Third party cash receipting
- Valid vendors

INFORMATION ABOUT THE CITY

The City of Connell serves 3,190 citizens in Franklin County. The City provides an array of services including water, sewer, police, parks and recreation, library, community center, swimming pool, street improvements, planning and economic development. The City contracts for solid waste collection and disposal services.

An elected, five-member Council and a separately elected Mayor govern the City. The Council appoints management to oversee the City's daily operations as well as its approximately 20 full-time employees. For 2013 2014, and 2015 the City operated on annual budgets of approximately \$9.9 million, \$12.3 million and \$11.8 million, respectively.
