## **AUDIT SUMMARY**

#### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of North Bend Transportation Benefit District No. 1 from January 1, 2014 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

• Use of restricted funds

## INFORMATION ABOUT THE DISTRICT

North Bend Transportation Benefit District No. 1 is located near Mount Si in King County. The City of North Bend created the Transportation Benefit District via Ordinance July 19, 2011.

The City manages the funds for the District and has all seven of the City Council Members sitting on the Board. The District authorized submission of a proposition for a sales and use tax at a rate of 0.2 percent to be used exclusively for identified transportation improvements, which was passed in the November 2011 general election. The District determined that it was important to propose transportation improvements that focus on both the residential and commercial sectors of the community.
