#### AUDIT SUMMARY

#### **Results in brief**

In the areas we audited, County operations complied with applicable requirements and provided adequate safeguarding of public resources. The County also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of Asotin County from January 1, 2015 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the County's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- General disbursements
- County Fair cash receipting
- Safeguarding of assets military surplus
- Financial condition

- Insurances/risk management requirements
- Payroll/personnel
- Sheriff Department citations

## **INFORMATION ABOUT THE COUNTY**

Asotin County was founded in 1883 and currently serves approximately 22,100 citizens. The County provides an array of services including public safety, road improvements, solid waste storm water, health and social services, Superior and District Courts, recreation and general administrative services.

An elected, three-member Board of Commissioners governs the County. The Commissioners oversee the operations as well as its approximately 120 employees. For the 2015 fiscal year, the County operated on an annual budget of \$22 million.
