## AUDIT SUMMARY

### Results in brief

In the areas we audited, Housing Authority operations complied with applicable requirements and provided adequate safeguarding of public resources. The Housing Authority also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of the Housing Authority of the City of Seattle from January 1, 2015 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Housing Authority's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Financial condition
- Open public meeting minutes
- Safeguarding of small and attractive assets such as computers
- Payments/expenditures
- Payroll/personnel
- Cash receipting/cash handling

## RELATED REPORTS

### **Financial**

A financial statement audit was performed by a firm of certified public accountants. That firm's report is available from Housing Authority of the City of Seattle.

### **Federal grant programs**

A firm of certified public accountants evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the Housing Authority's major federal programs. That firm's report is available from Housing Authority of the City of Seattle.

## INFORMATION ABOUT THE HOUSING AUTHORITY

The Housing Authority of the City of Seattle is the largest housing authority in the Pacific Northwest and the 24th largest in the United States. The City of Seattle created the Seattle Housing Authority in 1939. The Housing Authority owns and operates about 5,200 public housing units subsidized by the U.S. Department of Housing and Urban Development and manages approximately 2,800 units in other housing programs. The Housing Authority administers a federal grant program providing rental vouchers for just over 10,000 households. This provides safe and affordable living environments to over 29,100 low-income residents.

The Mayor of Seattle appoints the seven-member Board of Commissioners to staggered, five-year terms. The Board appoints an Executive Director to administer daily operations. The Housing Authority has approximately 550 employees. Funding to cover housing costs and operations consists of federal operating subsidies, grants, rent, miscellaneous fees and investment income. The Authority is redeveloping existing projects. This redevelopment is largely funded by federal grants, state and city funds, and tax credit investments through limited partnerships and bonds. For 2015, the Housing Authority had operating revenues and expenditures of \$195.70 million and \$174.49 million, respectively.
