## AUDIT SUMMARY

### Results in brief

In the areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of the City of North Bend from January 1, 2014 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Procurement (bidding/prevaling wage)
- Contract monitoring
- Information technology/data security
- Financial condition

## INFORMATION ABOUT THE CITY

The City of North Bend is located near Mount Si in King County and serves a population of approximately 6,570 citizens. The primary local funding source for the City comes from taxes paid by consumers and businesses. The City operates an annual budget of \$15.5 million, including utilities and capital projects.

A seven-member Council, headed by the Mayor, who, with the City Administrator, oversees day-to-day operations. The City has approximately 33 employees. The City provides services to its residents including utilities (water, sewer, storm and garbage), parks, building inspection and planning services. The City contracts for its police, fire and Municipal Court services with the City of Snoqualmie, Eastside Fire and Rescue and the City of Issaquah, respectively.
