AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of King County Water District No. 49 from January 1, 2015 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Procurement (bidding/prevailing wage)
- Credit cards and accounts
- Financial condition
- Payroll/personnel Payouts at termination

INFORMATION ABOUT THE DISTRICT

King County Water District No. 49 is a municipal corporation formed in King County. The District's primary activity is to provide water services to approximately 16,000 residential and commercial users within the District's boundaries, which encompass parts of Burien, SeaTac and Normandy Park. Its primary source of revenue is water sales, and it purchases all of its water from the City of Seattle.

The District is governed by an elected, three-member Board of Commissioners. The Board appointed a Superintendent and Office Manager to oversee the District's daily operations as well as its seven employees. During 2015, the District generated approximately \$3.9 million in operating revenues.
