## AUDIT SUMMARY

### Results in brief

In the areas we audited, Commission operations complied with applicable requirements and provided adequate safeguarding of public resources. The Commission also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of the Washington State Beer Commission from January 1, 2013 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Commission's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Cash receipting and revenue
- Expenditures, vouchers and credit cards
- Contracts and agreements

## INFORMATION ABOUT THE COMMISSION

The Washington State Beer Commission was formed in 2006 by state law to promote more than 340 microbreweries in the state. It is funded primarily by beer tasting festivals arranged by the Commission and assessments on local breweries.

The Commission is governed by a seven-member Board of Commissioners appointed by the Washington State Department of Agriculture. Revenue in fiscal years 2013, 2014 and 2015 were approximately \$976,000, \$945,000 and \$1,070,000, respectively.
