AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the North Central Regional Library from January 1, 2013 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Financial condition
- Self-insurance
- Bid law compliance
- Small and attractive assets
- Deposit compliance
- Disbursement system review

INFORMATION ABOUT THE DISTRICT

The North Central Regional Library District is an inter-county rural library district providing services to patrons in Chelan, Douglas, Okanogan, Grant and Ferry counties through 30 branch locations. The District also operates a mail order service from its main District headquarters in Wenatchee. Most of the District's funding comes from property tax levies. The District will generate approximately \$11.8 million in revenue for 2017 and operate on a \$13.3 million budget for 2017 with an additional \$2.1 million of Transfers to Designated Funds and expenses for specific projects and purchases.

A seven-member Board of Trustees governs the District. Board Members are jointly appointed by the county commissions from the five counties the District serves. The Board appoints a Director who is responsible for the District's daily operations as well as its 200 full- and part-time employees.
