#### **AUDIT SUMMARY**

#### **Results in brief**

In the areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of the City of Ocean Shores from January 1, 2015 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Financial condition
- Cash receipting Municipal Court
- Cash receipting Utility Dept.
- Cash receipting Convention Center
- Payroll overtime and military pay
- Self-insurance unemployment
- Surplus property (LID)
- Cost allocation plan

#### **INFORMATION ABOUT THE CITY**

The City of Ocean Shores, located in Grays Harbor County, was incorporated in 1970. The City provides its 5,955 citizens a wide range of services including public safety, fire prevention, street improvements, parks and general administration. In addition, the City operates water and sewer systems, a library and an airport.

The City formerly operated under a council-manager form of government with five elected Council Members, one of whom served as the Mayor. In 2008 the City converted to a council-mayor form of government with seven elected Council Members and an independently elected Mayor. The Mayor oversees the City's daily operations as well as its 77 employees. For 2015, the City operated on a \$28.6 million budget.
