AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Kitsap Regional Library from January 1, 2014 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Insurance/risk management
- Payroll/personnel
- Procurement

- Foundation
- Payments/expenditures
- Statutory authority

INFORMATION ABOUT THE DISTRICT

The Kitsap Rural Library District, doing business as Kitsap Regional Library, serves Kitsap County's residents through nine library branches located in the communities of Bremerton, Port Orchard, Poulsbo, Bainbridge Island, Silverdale, Manchester, Kingston and Little Boston; online access, a traveling bookmobile, and outreach services for the homebound and youth.

A five-member Board of Trustees, appointed by the Kitsap County Board of Commissioners, governs the District. The Board appoints a Library Director to oversee the District's daily operations as well as its approximately 200 employees. For 2014 and 2015, the District operated on annual budgets of approximately \$11 million.
