#### AUDIT SUMMARY

#### **Results in brief**

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of the Clinton Water District from January 1, 2013 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Accounting/financial reporting
- Financial condition

- Cash receipting
- Disbursements

## INFORMATION ABOUT THE DISTRICT

The Clinton Water District was organized in 1945 and is located in Clinton on the southern end of Whidbey Island, which is part of Island County. The District's service area covers approximately three square-miles, includes 13.2 miles of water mains from six wells, and serves 757 connections.

An elected, three-member Board of Commissioners governs the District. The Board appoints a District Manager to oversee the District's daily operations and its two employees. For 2013, 2014 and 2015, the District operated on budgets of \$349,500, \$360,000 and \$368,000, respectively.
