AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the South Whatcom Fire Authority from January 1, 2014 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Cash receipting
- Credit cards
- Disbursements

INFORMATION ABOUT THE DISTRICT

South Whatcom Fire Authority provides fire protection and emergency medical services to residents of south Whatcom County. Whatcom County Fire Protection Districts Nos. 2, 6, 9 and 10 combined to form the Authority, which began operations on January 1, 2009. The merged fire districts were officially dissolved as of January 1, 2010.

An elected, five-member Board of Commissioners governs the Authority. The Board appoints a Fire Chief to oversee the Authority's daily operations as well as its nine full-time employees, two part-time employees and 75 volunteer firefighters. For 2014 and 2015 the District operated on an annual budget of approximately \$2,489,741 million and \$2,508,078 million, respectively.
