## AUDIT SUMMARY

### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of Whatcom County Fire Protection District No. 1 from January 1, 2013 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Cash receipting
- Payroll
- Bid compliance

## INFORMATION ABOUT THE DISTRICT

Whatcom County Fire Protection District No. 1 provides fire protection and emergency medical services to about 11,000 residents in an area approximately 75 square miles that includes the Cities of Everson, Nooksack and the surrounding rural community.

An elected, three-member Board of Commissioners governs the District. The District has approximately 30 volunteer firefighters and four full time employees including a Fire Chief that oversees its daily operations. The District's main source of revenue comes from property taxes. Its total expenditures for fiscal years 2013, 2014 and 2015 were \$679,398, \$683,127 and \$752,089, respectively.
