#### **AUDIT SUMMARY**

#### Results in brief

In most areas we audited, County operations complied with applicable requirements and provided adequate safeguarding of public resources. The County also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to County management in a letter dated January 24, 2017, related to safeguarding public assets. We appreciate the County's commitment to resolving those matters.

#### About the audit

This report contains the results of our independent accountability audit of Snohomish County from July 1, 2015 through June 30, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the County's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Safeguarding public assets
- Airport department review
- Refunds of forest fire protection assessments
- Compliance with courthouse bond covenants
- Computer software system reviews
- Cash receipting

- Financial condition
- Payment of invoices
- Property tax refunds
- Expenditures using purchasing cards and store accounts

#### INFORMATION ABOUT THE COUNTY

As of December 31, 2015, Snohomish County had a population of approximately 772,501 citizens.

The County is governed by an elected, five-member County Council. Additional elected officials include County Executive, Prosecuting Attorney, Sheriff, Auditor, Clerk, Treasurer and Assessor. The County has 15 Superior Court judges and 8 District Court judges who are also elected. All County officials are elected to serve four-year terms.

The County's 2,700 full-time employees provide an array of services including public safety, law enforcement, fire prevention, road construction and maintenance, parks and recreation, judicial administration, health and social services and general administration. The County also operates an airport and fairground and is responsible for disposal of solid waste and controlling surface water run-off. For fiscal year 2015, the County had general fund expenditures of \$215,558,305, excluding transfers out of \$7,184,272.
