AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Cascade Valley Hospital and Clinics from January 1, 2014 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Open Public Meetings Act
- Financial condition
- Accounts receivable: pre and post lease
- Safeguarding of assets
- Final payroll: pre-lease
- Contract compliance

INFORMATION ABOUT THE DISTRICT

Snohomish County Public Hospital District No. 3 was created in 1964 to provide hospital and emergency services in the northeastern portion of Snohomish County. The District serves the cities of Arlington and Darrington.

Until June 1, 2016, the District operated Cascade Valley Hospital and Clinics, which includes Cascade Valley Hospital. The Hospital is a licensed 48-bed facility located on a campus of approximately 17 acres in the city of Arlington. In addition to the Hospital, until June 1, 2016, the District also operated a freestanding ambulatory surgery center and five medical clinics.

As of June 1, 2016, the District leased the hospital and its clinics to Public Hospital District No. 1, Skagit County, Washington, which does business as Skagit Regional Health. The initial term of the lease is 30 years. An elected, five-member Board of Commissioners governs the District. The Board appoints a superintendent to oversee the District's daily operations. The District currently employs four persons.
