#### **AUDIT SUMMARY**

#### Results in brief

In most areas we audited, Agency operations complied with applicable requirements and provided adequate safeguarding of public resources. The Agency also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to Agency management in a letter dated February 14, 2017, related to Air Operating Permit fees and billing We appreciate the Agency's commitment to resolving those matters.

#### About the audit

This report contains the results of our independent accountability audit of the Benton Clean Air Agency from July 1, 2014 through June 30, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Agency's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Benefits policy
- Credit cards
- Point & Pay system

- General disbursements
- Financial condition

#### INFORMATION ABOUT THE AGENCY

The Benton Clean Air Agency was originally established in 1970 as the Benton-Franklin-Walla Walla Counties Air Pollution Control Authority. Walla Walla withdrew from the Authority in 1993 and the Authority's name was changed to the Benton Franklin County Clean Air Authority. Franklin County withdrew from the Authority in 1995 and the Authority's name was changed to the Benton County Clean Air Authority. In 1998, the Authority's name was changed to the Benton Clean Air Authority. Finally, the Authority changed its name to the Benton Clean Air Agency in 2007. The mission of the Authority is to preserve, protect and enhance air quality for the benefit of the public, human health, safety and enjoyment of life, property and natural attractions, in balance with economic and social wellbeing.

An appointed five-member Board of Directors governs the Agency. Two Board Members are appointed by Benton County Commissioners, two Board Members are appointed by the City Selection Committee, and one additional Member is designated by the above four appointees. The Agency currently has five full-time employees and had operating expense of \$571,021 and \$557,185 in fiscal years 2015 and 2016, respectively.
