#### **AUDIT SUMMARY**

#### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of the North Whidbey Park and Recreation District from January 1, 2013 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

#### INFORMATION ABOUT THE DISTRICT

The North Whidbey Park and Recreation District provides recreational services to approximately 40,100 people primarily in the northern portion of Whidbey Island located in Island County. The District operates a swimming pool in Oak Harbor and owns and manages two ball fields and an off-leash dog park.

An elected, five-member Board of Commissioners governs the District. The Board appoints the Executive Director who supervises a staff of over 50 primarily part-time employees. The District operates on an annual budget of approximately \$990,000. Property taxes provide more than 50 percent of its revenue and the remainder is from program fees, concessions sales and other special events.
