AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of North Whatcom Fire & Rescue from January 1, 2014 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Open Public Meetings Act
- Self-insurance
- Third party billing and receipting
- Mitigation fees

INFORMATION ABOUT THE DISTRICT

Whatcom County Fire Protection District No. 21, doing business as North Whatcom Fire & Rescue, was formed in 2006 from a vote to merge two Whatcom County Fire Districts. In 2011, North Whatcom Fire & Rescue completed a functional consolidation with Whatcom County Fire District No. 4. The total consolidated service area covers 182 square miles of Whatcom County.

A Board of five Commissioners governs the District. The District has 48 full-time firefighters, 50 volunteer firefighters, eight support staff, and two mechanics. The governance and operations of the District are supported primarily through property taxes. The District's operating expenditures were \$6.8 million and \$7.0 million in 2014 and 2015, respectively.
