AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of Chelan County Fire Protection District No. 6 from January 1, 2013 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Self-insurance (unemployment)
- Petty cash / revolving fund
- Procurement

- Contracts and agreements
- Grant compliance

INFORMATION ABOUT THE DISTRICT

Chelan County Fire Protection District No. 6 is located in Chelan County. It provides fire protection and emergency medical aid services to the residents of Monitor, Cashmere, Peshastin, Dryden and surrounding areas.

An elected, three-member Board of Commissioners governs the District. The Board appoints a Fire Chief to oversee the District's daily operations as well as its 35 volunteer firefighters. The District operated on annual budgets of approximately \$506,000 in 2013, \$704,000 in 2014 and \$588,000 in 2015. Chelan County is the ex-officio Treasurer for the District.
