#### AUDIT SUMMARY

#### **Results in brief**

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of the Manchester Water District from January 1, 2013 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Utility adjustments
- Cash receipting

- Financial condition
- General disbursements

## **INFORMATION ABOUT THE DISTRICT**

The Manchester Water District was formed in 1942 and construction of the water system started in 1947. The District serves approximately 9,000 Kitsap County citizens in the unincorporated areas of Manchester, South Colby, Harper and Southworth. The District also operates street lighting systems in various portions of its service territory. The District operated on revenues of approximately \$2.2 million in 2015.

An elected, three-member Board of Commissioners governs the District. The Board appoints a General Manager to oversee the District's daily operations.
