AUDIT SUMMARY

Results in brief

In most areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to City management in a letter dated February 13, 2017, related to the City's interfund loans. We appreciate the City's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of the City of Sumner from January 1, 2015 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

• Financial condition

• Interfund transactions/balances

• Insurance/risk management

• Golf course sale

Financial

Our opinion on the City's financial statements and compliance with federal grant program requirements is provided in a separate report, which includes the City's financial statements. That report is available on our website, <u>http://portal.sao.wa.gov/ReportSearch</u>.

That report includes a finding for a significant deficiency in internal controls over financial reporting regarding internal controls over Financial Statement preparation and review.

We evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the City's major federal programs, which are listed in the Schedule of Findings and Questioned Costs section of the separate financial statement and single audit report. INFORMATION ABOUT THE CITY

The City of Sumner, incorporated in 1891, is located in eastern Pierce County and serves a population of approximately 9,700 citizens. The City provides services including law enforcement, public works, utilities (water, sewer and storm sewer), planning and zoning, animal control, parks and recreation, a senior center, and a cemetery.

An elected, seven-member Council and a separately elected Mayor govern the City. Council Members and the Mayor serve staggered, four-year terms. The Council appoints a City Administrator to oversee the City's operations as well as its approximately 103 employees. The City operates on a biennial budget. The City had approximately \$53 million in expenditures during fiscal year 2015.
