AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of Skagit County Fire Protection District No. 6 from January 1, 2013 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Payroll
- Bank accounts
- Credit card disbursements

INFORMATION ABOUT THE DISTRICT

Skagit County Fire Protection District No. 6 provides emergency response services to approximately 5,500 residents in a 27 square-mile area.

An elected, three-member Board of Commissioners governs the District. The Board appoints a part-time Fire Chief and Secretary to oversee the District's daily operations as well as its 24 volunteer firefighters. For fiscal years 2013, 2014 and 2015, the District operated on annual budgets of \$1,833,626, \$986,824 and \$842,015, respectively.
