AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of Water District No. 19 from January 1, 2013 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Cash receipting
- Credit cards
- General disbursements
- Procurement
- Self-insurance
- Travel reimbursements

INFORMATION ABOUT THE DISTRICT

Water District No. 19 was established in 1925 to provide a safe water supply for the residents of Vashon Island. The District is the only public water system on Vashon, serving 1,474 customers within six square-miles of the central eastern portion of the Island.

An elected, three-member Board of Commissioners governs the District. Board Members are elected to serve staggered, six-year terms. The District has five full-time employees and one part-time employee. The District has a moratorium on new hookups that is not expected to end in the foreseeable future. The District collects approximately \$1.3 million annually in water utility revenue. District expenditures were \$951,742 for 2015, \$825,071 for 2014 and \$1,330,834 for 2013.
