## **AUDIT SUMMARY**

#### Results in brief

In the areas we audited, Town operations complied with applicable requirements and provided adequate safeguarding of public resources. The Town also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of the Town of Eatonville from January 1, 2014 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Town's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Open Public Meetings Act
- Financial condition
- Payroll

- Restricted funds
- Federal expenditures/revenues
- Permits

The Town of Eatonville serves approximately 2,758 citizens in Pierce County.

The Town operates under a Mayor - Town Council form of government with an elected, five-member Council and an independently elected Mayor. The Town operated on annual expenditures of approximately \$7.4 million for 2014 and \$6.5 million for 2015. The Town provides municipal services including police, electricity, water, sewer and garbage. Further, the Town operates a community center, airport and cemetery.
