AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of Mason County Fire Protection District No. 4 from January 1, 2013 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Financial condition
- Payroll/personnel
- Surplus property

- Fuel cards
- Procurement

INFORMATION ABOUT THE DISTRICT

Mason County Fire Protection District No. 4 is responsible for the Arcadia-Kamilche area of south Mason County. The District's service area covers approximately 52 square-miles and serves approximately 6,700 residents. The District provides a full range of services including fire suppression, basic life support transports, vehicle extrication and rope rescue.

An elected, three-member Board of Commissioners governs the District. The Board appoints a Fire Chief to oversee the District's daily operations. The District had revenues of approximately \$1 million for each of the years under audit.
