### **AUDIT SUMMARY**

#### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of the Chief Kitsap Academy from September 1, 2014 through August 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Student enrollment reporting
- Teacher education and experience (staff mix) reporting
- Student transportation reporting
- Payroll

# INFORMATION ABOUT THE DISTRICT

The Squamish Tribal Education Department No. 902 opened Chief Kitsap Academy in September 2014 as the first of three Washington State Tribal Compact Schools. The Tribal school is located in Kitsap County.

For school year 2015, Chief Kitsap Academy served approximately 78 students in grades 6-12. The school received approximately \$1.5 million in direct state funding for fiscal year 2015. As a sovereign nation, the Suquamish Tribal Council has the ultimate control over the educational needs of the students at Chief Kitsap Academy.
