AUDIT SUMMARY

Results in brief

In most areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to District management in a letter dated February 23, 2017, related to safeguarding small and attractive technology assets. We appreciate the District's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of Anacortes School District No. 103 from September 1, 2013 through August 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Foundation relationship and donation receipting
- Basic enrollment
- Associated Student Body

INFORMATION ABOUT THE DISTRICT

Anacortes School District No. 103, located in Skagit County on Fidalgo Island, provides educational services for approximately 2,732 students in grades kindergarten through 12th. The District has one high school, one alternative high school, one middle school and four elementary schools.

An elected, five-member Board of Directors governs the District. The Board appoints a Superintendent to oversee the District's day-to-day operations as well as its staff of 188 certificated and 207 classified employees. The District operated on a budget of \$27,691,000, \$29,110,000 and \$31,819,000 for fiscal years 2014, 2015 and 2016, respectively.
