AUDIT SUMMARY

Results in brief

In the areas we audited, Program operations complied with applicable requirements and provided adequate safeguarding of public resources. The Program also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Schools Insurance Association of Washington from September 1, 2014 through August 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Program's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Contracts/agreements
- Investments
- Disbursements

INFORMATION ABOUT THE PROGRAM

The Schools Insurance Association of Washington was formed by through an inter-local agreement among seven founding school districts in 1995. The inter-local agreement allows the joint purchase of insurance, joint self-insuring, joint hiring or contracting for risk management services and claims administration. As of the end of fiscal year 2016 there were 37 member districts in the Program.

The Program is regulated by the state Office of Risk Management with the Department of Enterprise Services. An elected, eight-member Board of Directors governs the Program's activities. For fiscal years 2015 and 2016, the Program operated on annual budget of approximately \$28 million and \$29.8 million, respectively.
