#### **AUDIT SUMMARY**

#### Results in brief

In most areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to City management in a letter dated April 6, 2017, related to allocation of wages to restricted and proprietary funds. We appreciate the City's commitment to resolving those matters.

#### About the audit

This report contains the results of our independent accountability audit of the City of Pateros from January 1, 2014 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

• General disbursements

Utility billing adjustments

Cost allocation

#### INFORMATION ABOUT THE CITY

The City of Pateros was incorporated in 1913 and currently serves 665 citizens in Okanogan County. An elected, five-member City Council governs the City with an independently elected Mayor. Its eight employees provide an array of services including water, sewer, parks, public improvements, planning and economic development. The City also provides fire protection with a volunteer department.

The City operates on an annual budget of approximately \$1.4, \$1.6 and \$2.6 million for fiscal years 2014, 2015 and 2016, respectively.
