#### AUDIT SUMMARY

#### **Results in brief**

In most areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in most areas we examined.

However, we noted certain matters that we communicated to the District management in a letter dated April 6, 2017 related to use of booster clubs for ASB activities. We appreciate the District's commitment to resolving those matters.

## About the audit

This report contains the results of our independent accountability audit of University Place School District No. 83 from September 1, 2015 through August 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Associated Student Body (ASB)
- Career and technical education enrollment reporting

- Food service revenues
- Teacher education and experience (staff mix) reporting

## INFORMATION ABOUT THE DISTRICT

University Place School District No. 83 serves approximately 5,500 students from pre-school through 12th grade in Pierce County. The District operates four elementary schools, two intermediate schools, one junior high school and one senior high school. The District has approximately 800 full- and part-time employees including administrators, teachers, substitutes and support staff.

An elected, five-member Board of Directors governs the District. Board Members are elected to staggered, four-year terms. The Board appoints the District's Superintendent, who serves as the chief administrative officer of the District. The District's general fund annual budget was approximately \$62 million in fiscal year 2016.
