AUDIT SUMMARY

Results in brief

In most areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to District management in a letter dated April 10, 2017, related to the procurement of public works projects. We appreciate the District's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of the Educational Service District No. 112 from September 1, 2015 through August 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Contract/agreements
- Insurance/risk management
- Open public meeting minutes
- Payments/expenditures
- Payroll/personnel

- Procurement (bidding/prevailing wage)
- Legal authority
- Use of restricted funds

INFORMATION ABOUT THE DISTRICT

Educational Service District No. 112, located in Clark County, provides cooperative and informational services to 30 school districts, two state schools and numerous private schools to assure equal educational opportunities throughout southwest Washington. The District is one of nine Educational Service Districts in the state of Washington. The services provided include curriculum, instructional support and assessment, business operations, transportation, youth employment, printing, public relations, data processing, payroll, fingerprinting, network support, a statewide K-20 computer network, traffic safety education, construction management, preschool programs, homeless transportation, risk management, childcare, para-educator training and special education.

An elected, seven-member Board of Directors provides oversight and fiscal responsibility for the District's operations. The Board appoints management to oversee the District's operations as well as its more than 500 employees. For fiscal year 2016, the District operated on annual revenues of \$72.2 million.
