AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Valley View Sewer District from January 1, 2015 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Cash receipting
- Travel costs
- Records retention policy

INFORMATION ABOUT THE DISTRICT

The Valley View Sewer District provides sewer service to approximately 9,000 customers. The service area includes portions of the cities of SeaTac, Burien and Tukwila and unincorporated King County. The District provides collection and transmission services, but other districts and King County provide treatment services.

An elected, three-member Board of Commissioners governs the District. The Board appoints a General Manager to oversee the District's daily operations as well as its 17 employees. For 2015, the District operating revenues were \$11,377,395. On November 23, 1995, the Rainier Sewer District merged into the Val Vue Sewer District. In 2007, it officially changed its name from the Val Vue Sewer District to the Valley View Sewer District.
