## AUDIT SUMMARY

### Results in brief

In the areas we audited, Authority operations complied with applicable requirements and provided adequate safeguarding of public resources. The Authority also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of the Pierce County Public Transportation Benefit Area Authority (Pierce Transit) from January 1, 2015 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Authority's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Open Public Meetings Act
- Payroll
- One Regional Card for All (ORCA) card use

## INFORMATION ABOUT THE AUTHORITY

Pierce Transit was formed in 1979 when voters passed a .3 percent sales tax to fund public transportation service to Pierce County. In 2002, Pierce County voters approved an increase to the local sales tax support from .3 percent to .6 percent. Pierce Transit also operates fixed route, specialized transportation (SHUTTLE) services for the elderly and disabled, and vanpool transportation services.

Pierce Transit is governed by a 10-member Board of Commissioners. The Board is made up of elected officials representing Pierce County, Tacoma, Lakewood, Puyallup, University Place, the smaller towns and cities in the service area and one nonvoting Union Representative. Commissioners serve three-year terms. The Board appoints management to oversee Pierce Transit's daily operations as well as its approximate 900 employees. Pierce Transit serves approximately 70 percent of Pierce County's residents. Its service area covers 292 square miles.

During 2015, Pierce Transit's operating revenue totaled more than \$49.6 million. In addition, Pierce Transit received operating subsidies of more than \$82 million in sales tax revenue and in operating and capital grants.
