AUDIT SUMMARY

Results in brief

In most areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to District management in a letter dated April 11, 2017, related to compliance with procurement requirements of architecture and engineering services. We appreciate the District's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of Pasco School District No. 1 from September 1, 2015 through August 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Compliance with Career Technical Education requirements
- Compliance with procurement of public works projects
- Compliance with procurement of architecture and engineering services
- Review of payroll disbursements
- Review of general disbursements for compliance with district policy
- Cash receipting procedures for Associated Student Body store
- Hotline review of teacher selling snacks

INFORMATION ABOUT THE DISTRICT

Pasco School District No. 1 serves approximately 17,000 school children from the City of Pasco and unincorporated Franklin County. There are 20 campuses in the District: eight elementary schools (K-5), four elementary schools (1-5), one early learning center (Kindergarten), three middle schools (6-8), two four-year high schools (9-12) and an alternative middle and secondary school (6-12) as well as the state's first Science, Technology, Engineering and Mathematics (STEM) high school, Delta.

An elected, five-member Board of Directors governs the District. The Board appoints a Superintendent to oversee the District's daily operations as well as its approximately 1,123 certificated staff and 860 classified staff. For fiscal year 2016, the District's expenditures were approximately \$228 million.
