AUDIT SUMMARY

Results in brief

In the areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the City of SeaTac from January 1, 2015 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Financial condition
- Cash receipting
- Court operations

- Small and attractive assets
- Use of restricted funds
- Credit cards and accounts

INFORMATION ABOUT THE CITY

The City of SeaTac was incorporated on February 28, 1990, and is located midway between the cities of Seattle and Tacoma. The City provides its approximately 27,810 citizens with local government services including fire prevention and protection, police services, Municipal Court, storm water utility, community and economic development, parks and recreation, land use management and public works.

An elected, seven-member Council governs the City. The Council elects one of its members to serve as Mayor for a two-year term. In addition, the Council appoints management to oversee the City's daily operations as well as its 125 full-time equivalent employees. For 2015, the City had an operating and capital budget of \$66 million.
