AUDIT SUMMARY

Results in brief

In the areas we audited, Association operations complied with applicable requirements and provided adequate safeguarding of public resources. The Association also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Washington State School Directors' Association from January 1, 2014 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Association's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Self-insurance
- Cash receipting
- Billing and adjustments

- Payroll
- Disbursements
- Open public meeting

INFORMATION ABOUT THE ASSOCIATION

The Washington State School Directors' Association serves 1,477 school directors from the state's 295 school districts. The Association provides leadership, advocacy, and empowers its members with knowledge and skills to govern with excellence.

Oversight responsibility for the Association's operations is vested with the independently elected, 16-member Board of Directors. Board Members are elected by the membership at its annual conference. The Board appoints an Executive Director to oversee the Association's daily operations as well as its 16 employees. For the years under audit, the Association operated on annual budgets of approximately \$3.1 million in revenues and 2.8 million in expenditures.
