## AUDIT SUMMARY

### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of Snoqualmie Valley School District No. 410 from September 1, 2015 through August 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Procurement (bidding/prevaling wage)
- Insurance/risk management
- Teacher education and experience (staff mix) reporting
- Student transportation reporting

## INFORMATION ABOUT THE DISTRICT

Snoqualmie Valley School District No. 410 is located in the foothills of the Cascade Mountains and covers 400 square miles serving the communities of Snoqualmie, North Bend, Fall City and surrounding areas of unincorporated King County. The District serves about 6,300 students and families with six elementary schools, two middle schools, one comprehensive high school, and one alternative school.

An elected, five-member Board of Directors governs the District. The Board appoints the Superintendent to oversee the District's daily operations as well as its 702 employees. For fiscal year 2016, the District's general fund operated on an annual budget of approximately \$70.9 million.
