### **AUDIT SUMMARY**

#### Results in brief

In most areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in most areas we examined.

However, we noted certain matters that we communicated to District management in a letter dated May 18, 2017, related to procurement. We appreciate the District's commitment to resolving those matters.

#### About the audit

This report contains the results of our independent accountability audit of Hoquiam School District No. 28 from September 1, 2015 through August 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Open public meetings
- Career and Technical Education (CTE)
- Procurement public works
- Procurement purchases
- Financial condition

- Internal controls over:
  - Small and attractive assets
  - General disbursements
  - Payroll expenditures

# INFORMATION ABOUT THE DISTRICT

Hoquiam School District No. 28 provides education and related services to approximately 1,700 pre-school through 12th grade students in the city of Hoquiam and the surrounding area. The District provides basic education, supplemental programs and learning opportunities such as Special Education and English as a Second Language. In addition, the District offers food service, office and special education assistants. Transportation needs are met through the Hoquiam-Aberdeen Transportation Cooperative. The District has five schools: three elementary, one middle school and one high school as well as online learning through HomeLink.

An elected, five-member Board of Directors governs the District. Board Members are elected to staggered, four-year terms. The Board appoints a Superintendent to oversee the District's daily operations as well as its approximately 120 certificated and 125 classified employees.
